Introduction

This report describes the achievements of GIWEH from January 2014 to December 2014. It highlights key successes, challenges, and transitions that occurred during the year of 2014, as well as the vision for the future that GIWEH looks forward to, especially amid this sensitive time of global environmental changes that require more effective interventions that are well-oriented towards sustainability and achieving better results.

Background

Over the past seven years, the Global Institute for Water, Environment and Health (GIWEH) has worked to conserve the most scarce and vital resource in our planet: water. The creation of the institute is based on a strong conviction that in order for water to be conserved, a comprehensive approach should be initiated where stakeholders from different fields work together towards responding more effectively to the ever increasing threats to water resources and environmental safety.



Program Areas

The water crisis has never been more critical globally and is a top risk facing the world, according to the World Economic Forum's Global Risk Report 2015. The response to the water crisis has long focused on infrastructure such as installing water pumps and tabs. However, the infrastructure projects alone are not good enough, and a more holistic, long-term process is needed to respond to the global water crises.



Therefore, we at GIWEH believe that the response to the global water crisis goes beyond infrastructure, and so we focus on fostering good practices, knowledge and technology transfer in water scarce regions through the following:



In this context, GIWEH maintains trainings and internships, actively participates in international conferences, holds its own conference on water resource and environmental management (ICWRE), bring stakeholders together, conducts research and contributes in publications of key water-related international agencies.

Commitment to the Post-2015 Development Agenda


As part of its contribution to the post-2015 development agenda, GIWEH has embarked on two projects and intends to launch in 2015:

1) Flagship Project: Water Governance and Integrated Water Resource Management in Water Scarce Regions

As part of its contribution to the post-2015 development agenda's water goal, GIWEH has embarked on a project that focuses on water governance and integrated water resources management in water scarce regions. This project is based on GIWEH's previous and cur rent project experiences and targets vulnerable contexts such as rural areas, youth, and women who bear the brunt of water scarcity.

To enable the amelioration of conditions in water scarce regions, and particularly for the three target groups, GIWEH is undertaking a multi-faceted approach comprising four elements: capacity building, education and research, technology transfer and knowledge translation.

2) Water Monitoring Framework

GIWEH has started an initiative towards building a water monitoring framework that takes into consideration availability, viability, allocation, and supply-demand, and has clear measurable indicators. This framework should facilitate the global effort in responding more effectively to the water crisis.

Programs Success

Hosting the 3rd ICWRE – International Conference on Water Resources and Environmental Management (Antalya, Turkey)

GIWEH hosted its 3rd International Conference on Water Resources and Environmental Management (ICWRE) in Antalya, Turkey from 13th-15th May 2014. The conference's theme was the "Role of Governance in the Management of Water Resources and Environment", in a response to increasing water scarcity, environmental degradation and the UN 2014 year of 'Water and Energy'. GIWEH hosted the ICWRE to further contribute to these pressing issues.

ICWRE Key Outcomes

Cooperation

GIWEH and Graduate Institute visits to the West Bank, Palestine

In February 2014, GIWEH, represented by its director general Dr. Nidal Salim organized a visit to the West Bank, Palestine in cooperation with the Graduate Institute, Geneva - Switzerland and the University of Geneva represented by Dr. Alexander Dormier Freire.



The main objective of the visit was to discuss the different possibilities of cooperation to support the development agenda in the two countries mainly regarding water, agriculture and water governance. The team visited different related institutions from the public and private sectors and civil society, including the Ministry of Foreign Affairs, Ministry of Agriculture, Ministry of National Economy, and Ministry of

Planning, as well as Palestinian Universities: Birzeit University, An-Najah National University, and Palestine Technical University- Kadoorie. In addition to a number of organizations such as the Palestinian Hydrology Group, and the Palestine Economic Policy Research Institute (MAS).

These meetings sparked a strong interest among stakeholders for future cooperation and implementation of projects related to water in Palestine. GIWEH has been following up with these stakeholders to transform this interest into action.

Participation in International Conferences & Meetings

The Swiss Water Partnership (SWP) Post 2015 Advocacy Meeting (Bern, Switzerland)

GIWEH participated in the Swiss Water Partnership meeting on Post 2015 Advocacy on 24 January 2014 in Bern Switzerland. During this meeting, the Agenda on Global Sustainable Development in Post 2015 and an updated Swiss position on Water goal have been presented.

GIWEH fully supports the Swiss approach and is committed to advocate for a dedicated Water goal with sub-goals and targets in the post 2015 agenda. In the second part of the meeting, the members of the Swiss Water Partnership did a mapping of advocacy opportunities and planned advocacy actions. The Stockholm's World Water Week (Stockholm, Sweden)

31 August – 5 September 2014 in Stockholm, Sweden



It was a successful week of addressing the world's water, development and sustainability issues hosted by Stockholm International Water Institute (SIWI). This event attracted over 2,500 major participants and 200 collaborating organizations from around 130 countries all over the world.

The seminar prepared by the convening Swiss Water Partnership (SWP) and its co-conveners, including GIWEH, presented a series of advanced Swiss solutions to achieve water and energy security. This seminar presented titled "Tackling trade-offs between water and energy across sectors and scales" critically discussed in context of Tanzania and the Middle East and the potentials of scaling up. In addition, GIWEH exhibited in a co-owned booth with the Swiss Water Partnership and 9 other members, where GIWEH was able to share its current and future activities with participants and delegates.

The 53rd Board of Governors Meeting of the World Water Council (Marseille, France)

As a member of the World Water Council (WWC). **GIWEH** participated at the 53rd meeting **WWC** of the governors from 28-29 October 2014 in Marseille. France. The WWC's main obiective is the



inclusion of a standalone goal for water among the Post-2015 Sustainable Development Goals, which is under their mandate to promote awareness, build political commitment and trigger action on critical water issues and

bring stakeholders together. This Council brings 300 organizations from more than 50 different countries involving multi-stakeholder groups including intergovernmental organizations, national governments, the business sector, NGOs, water user associations, and academia. The Council's deciding body is comprised of 36 highly involved Governors. This meeting in Marseille specifically included GIWEH's participation in the roundtable discussions on major issues for 2015 namely the 7th World Water Forum and the water goal in the Post-2015 Development Agenda.

Goal Six - Supporting technology transfer, north-south cooperation, hydro diplomacy and trans-boundary resource management.

Goal Seven - Adapting clear and applicable monitoring indicators on high quality solutions for water security, particularly in water scarce regions.


